- An explanation of the grant's intended use, i.e. advanced-degree programs, real estate educational conferences or conventions.
- Three letters of recommendation, at least one of which must be from a member of the Association of Illinois Real Estate Educators. (Replies from these references are to be sent directly to the Foundation and are considered confidential and will not be revealed to the candidate.)
- Evidence that the applicant is an Illinois licensed pre-license or continuing-education instructor, in real estate and/or appraisal, or serves as a director of education for a real estate organization or school.

The selection of grant recipients will be determined by the AIREE Board of Directors, taking into consideration the items listed above.
